From North MS using Hwy 49: Take ramp right for I-59 North/MS 42 East Toward Laurel, MS. At exit 69, take ramp right for MS42 East toward Glendale, MS. Turn right onto MS 42/Evelyn Gandy Parkway toward Glendale, MS, then turn back on MS42/Highway 42. Arrive at MS 42/Highway 42 on the right. The last intersection is Sherwood Forest Drive. If you reach Wildwood Trail, you have gone too far.

From East or North using I-59: At exit 69, take ramp right for MS42 East toward Glendale, MS. Turn right onto MS 42/Evelyn Gandy Parkway toward Glendale, MS, then turn back on MS42/Highway 42. Arrive at MS 42/Highway 42 on the right. The last intersection is Sherwood Forest Drive. If you reach Wildwood Trail, you have gone too far.

From South MS using I-59: Take I-59 toward Hattiesburg, MS. At exit 69, take ramp right for MS42 East toward Glendale, MS. Turn right onto MS 42/Evelyn Gandy Parkway toward Glendale, MS, then turn back on MS42/Highway 42. Arrive at MS 42/Highway 42 on the right. The last intersection is Sherwood Forest Drive. If you reach Wildwood Trail, you have gone too far.
