

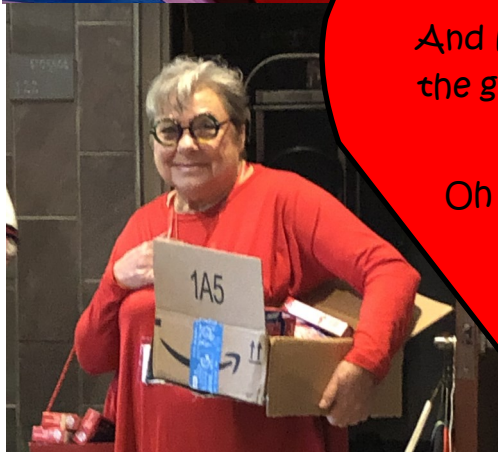

The new structure will include a scorecard as a new tool that was piloted in 2018 for judging of reports and has been revised to allow a more objective controlled and intentional approach. This MFWC Reporting Guide Playbook is also intended to ensure accountability and support throughout the reporting process.

The MFWC REPORTING GUIDE PLAYBOOK contains instructions for successfully completing reports for MFWC President's Special Project, GFWC Signature Programs, Community Service Programs, Advancement Areas, MFWC Special Emphasis, and Grand Initiatives. It has been designed to:: Provide step-by-step instructions to ensure all Club Presidents understand how to fill out the reporting statistical summary and program narratives.

Personal and club donations are always appreciated and may be mailed to me at any time during the year to honor or memorialize someone. A letter will be mailed to the honoree or her family as an acknowledgment of these gifts.

PLEASE DO NOT STAPLE CHECKS TO LETTERS OR FORMS. The holes cause the checks to snag in the bank counting machines.

IMPORTANT: If your district, club or an individual wishes to designate donations to a specific organization, i.e. Operation Smile, UNICEF, St. Jude, Heifer International, etc., you may do so, but **ALL** checks sent to the MFWC Treasurer **MUST BE MADE PAYABLE TO MFWC**, not the organization. I can neither deposit or disburse funds made payable to another organization.

Please make sure that members' email addresses are correct and up-to-date since this is one of the means of receiving MS Clubwoman magazine.



Fellow Clubwomen

If you will remember at the 2019 MFWC Convention, changes to our MFWC By-laws were unanimously approved. The headquarters committee membership was revised to reflect our redistricting that was effective in 2018. I would encourage each club/member to review their current bylaws to make sure that the club's bylaws are up to date. Also I would encourage each club/member to double check that you are indeed following your specified bylaws.

There are two items found within bylaws that I want to highlight: quorum and elections. One practice that you need to be sure to follow is the number of members who are needed for a quorum. Be sure that business is not conducted if a quorum is not present. Your bylaws should list the number of members needed to establish a quorum.

Another item that needs to be followed is your election of officers' procedure. Be sure that your nominating committee has the composition established in the bylaws. Also be sure that you follow the procedure if a paper ballot is required or a simple voice vote. If you require one and you wish to do something different, you will need a motion and approval to suspend the documented requirement. Again, if your practice has changed over time, you might consider changing your bylaws to fit your current practice.

Each meeting should have an agenda to guide the discussion. The reports can be adjusted to fit your practice and your bylaws.

What a wonderful year that we have had volunteering in our communities. Keep up the outstanding work and let me know if I can assist you in any way.

From Frances Brown, PSP Co-Chairman:

First, let me thank you for your overwhelming support of our President's Special Project. Because of your hard work and generosity, we were able to present a \$10,000 donation to the American Heart Association at State Convention in Starkville. Congratulations MFWC!!! Let's not stop now! We are only half way there. Be creative and continue to raise awareness and dollars to create a healthier Mississippi.

It is equally important that we continue to GO RED. Let's focus on the "R" for a moment... **RAISE** your voice. If you have not already, I would like for you to join President Wright in taking action to protect the heart of all those we love and hold dear, especially our children and grandchildren by asking Congress to raise the tobacco purchasing age to 21. An alarming 90% of smokers say they first tried a tobacco product before age 18 and many teens falsely believe new products like e-cigarettes are safe. One in five high school students are trying e-cigarettes and more young adults are using e-cigarettes, and using more often.



It's time for GFWC-Mississippi to take action to protect them. There are bills in Congress that would raise the purchasing age to 21 for tobacco products. We need to act now to encourage our congressmen to take action. Every voice counts! Please take seven minutes and join You're the Cure. You're the Cure is the American Heart Association's network of people who advocate for policies that support a heart disease and stroke-free America. At Summer Institute we learned that doing something is better than doing nothing. Hands Only CPR is simple and lifesaving. If feasible, I strongly encourage you to take CPR training; and if it's not an option, invite someone to your club meeting to demonstrate Hands Only CPR.

Another heart bullet on the PSP form is the Little Red Hats for pediatric heart patients. Thank you to all who brought hats to Winter Board. The table truly ran over with Little Red Crocheted Hats.

- Practice Heart Healthy changes in dietary behaviors (i.e. reduced sodium, increased fruits and vegetables)
- Improve cholesterol by decreasing intake of saturated fats and increasing fiber

- Walk in charity 5ks or fun runs

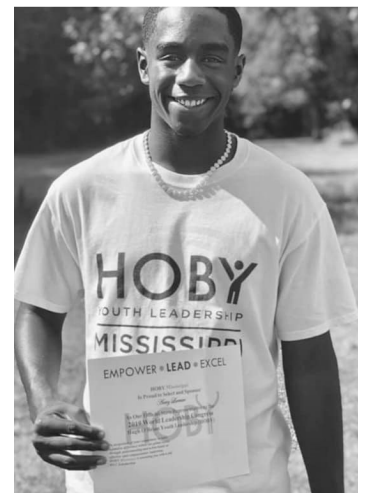

During that weekend they made friends with whom they will associate throughout their lives. Former AMBASSADORS, who had returned to assist during the weekend, were as enthusiastic as the new AMBASSADORS.

President Wright issued an invitation for the HOBY Board to conduct their September Board meeting at GFWC Headquarters. They gladly accepted and MFWC will host and provide lunch. The total cost for a student to attend HOBY is \$425.00. \$225.00 is the National fee and \$200.00, per student, is the cost for Mississippi to host the Seminar.

The Mississippi HOBY Foundation raises funds from organizations so that each school is able to send a student for the cost of the National fee. This means that organizations donate \$200.00. In the past schools would pay the other portion (\$225.00 National fee) for their student, so they would have a representative at the Seminar. More and more schools are unable to pay the National fee so the cost has been turned over to parents of the students in some cases.

Clubs who sponsor students pay their \$200.00 on the MFWC Dues Form. Schools must send the other \$225.00 directly to the HOBY national office in California. Mississippi HOBY does not handle this fee. It must be sent through the school using the registration and invoice system provided to schools at www.hoby.org.

At the conclusion of this year's Seminar, two students were selected, from the approximately 250 AMBASSADORS, to attend the World Leadership Conference at Loyola University Chicago. HOBY Mississippi will pay their expenses for the week long event which will include interactive educational programs that include hearing from top leaders in a variety of fields, hands-on workshops, community service projects and of course, some fun. Congratulations to the GFWC-MFWC Enterprise Woman's Club on the selection of their AMBASSADOR, Artez Lamar. What a wonderful opportunity for Lamar to continue his leadership journey!

If we are using envelope the return address on the envelope that should be written in red ink. And as the final appearance on the envelope write a LARGE red check on the front of the envelope.

Why use all of the red ink? To inform or remind the recipient that the MFWC and GFWC are large and effective volunteer organizations of women who stay busy involved in promoting events serving our communities, states and nation.

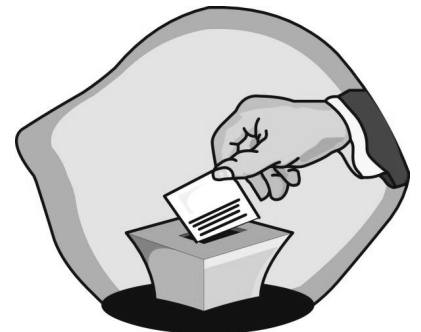
REMEMBER THE 1000 GOAL!!! The GFWC President is working toward adding 1,000 new GFWC Clubwomen to the Legislation Action Center (LAC) by 2020. Our Federation has had a good reputation for participating. Get on your computer and go to GFWC.org. Click on What We Do, then on Public Policy. The LAC page will come up. Click on the message "Join Now" and click on the box and fill the form that appears. Do it. You will be signed up for "Take Action".

GETTING READY FOR 2020 -- Mississippians are getting ready for the presidential election. There is already plenty of news filled events to keep qualified voters thinking about who will be chosen on the November 2020 general election ballot as the person who will be taking the oath of office to serve four years as the U.S. President.

On March 10, 2020 the Democratic candidates will on the open Democratic primary election ballot. Available news indicates that the Republican Party will not hold a primary election in Mississippi to allow potential voters to make their presidential choice known.

Also, be sure to plan some projects that partner with other groups, such as Scouts, school, church and/or civic organizations. Partnerships reach many more people than you can reach alone, and the effects can make an impact on your entire community and promote your club at the same time.*

When you plan and report your projects, designate one project to be judged for the Creativity Award. Report this project in great detail to allow judges to see the creativity.

Keep in mind the President's Grand Initiatives and suggested projects in GFWC Manual as you plan your projects. Be sure to use information from Summer Institute so that your projects will follow current guidelines. Program ideas are endless. Be creative and innovative - and REPORT. Thank you for your efforts.

Education Community Service Program

Wow! Another fall is upon us, with many opportunities to improve literacy, promote our libraries, and make our world a better place for lifelong learners.

In the coming year, consider other ways that you can be advocates for education in your clubs and in your communities. Think “outside the box” for creative solutions to age-old problems (adult literacy, poverty’s effect on child learning, promoting and participating in continuing education and life-long learning in areas with no institutions of higher learning, for some examples). Bring in a representative from a community college or university to talk about lifelong learning, if you are close to one. Also, if you have a local senior center, create a library or work with your local Friends of the Library to bring the Library to them.

President Brock has been overwhelmed by the response to her Seven Grand Initiatives, with over 50,716 Dr. Seuss books donated to GFWC and local projects. GFWC clubwomen have been challenged to raise the ante to 55,000 books by June 2020. With that in mind, and with a look at how we can reach people in our community who may not regularly go to the library, we are challenging each club to start a Laundry and Literacy project in their local laundromat. Clubs, with the owner’s permission and working in partnership with their local library and/or Friends of the Library organization can stock brightly colored laundry basket (or bookcase) filled with books (for children and adults), activities, coloring books, and other learning materials and place it in the laundromat, replenishing every few weeks as necessary. Some of these materials can be bilingual, so that not only are the children reading and learning, but their parents are as well. It is hoped that the patrons will take the books home and share them with the family. Used book stores, yard sales, and discount stores such as Ollie’s might be ways to keep the baskets stocked. Set up collection boxes for used books in your churches, banks, etc. Apply for a grant for materials from the Mississippi Library Commission; moneys are available to assist with projects in your community. Take a look at the GFWC Focus on Literacy Club Grant. These grants of \$200.00 may be used for purchasing books for tutors to use, providing books to children, and a variety of other literacy needs. The application and other suggestions may be found at www.GFWC.org/membership/awards-contests-and-grants/.

Keep supporting our graduating seniors and non-traditional students with your scholarships and grants! Mississippi’s clubwomen have always set scholarships as a priority in their education programs, and our students have never needed the financial assistance more with cost of higher education continually rising. When you create signage for your club events, make sure that you include the scholarships that your club offers. Your community may not be aware of what is available.

Please continue your work in your local schools. Mississippi clubwomen have always been generous with their time, donations, and materials in their local schools. Volunteer to tutor, chaperone field trips, and provide support for school events. Donate supplies, hands-on materials for preschools, and small recess and playground materials such as balls and jump ropes. Help establish an anti-bullying campaign if one has not already been established in your schools. Ask your school librarians if you can help with their needs.

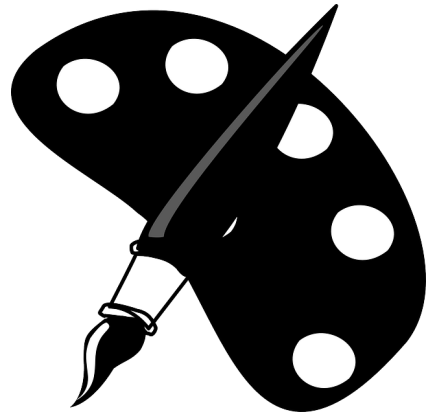
very many people and that he was "always be humble and kind".

GFWC-MFWC CHALLENGE GRANT

The Challenge Grant was established by GFWC-MFWC Clubwomen for the benefit of Mississippi educators who teach students with learning disabilities. Each year, funds not to exceed \$300.00 are available for multiple grants or a single grant that may be awarded at the discretion of the Committee formed to administer those grants. I currently chair the Committee that is also comprised of members Carolyn Tedford, Libby Everett, along with Ex-officio member, President Becky Wright.



All of the information that you need to apply for the grant is available on the GFWC-MFWC website, including the guidelines and the GFWC-MFWC Challenge Grant Application Form.

The submission must be postmarked by February 1 (or if that deadline falls on a Sunday or holiday, the application must be postmarked the prior day).

The guidelines require that the application be accompanied by two letters of recommendation: (1) from a school official and (2) from a member of the GFWC-MFWC sponsoring club.

The application also requires a detailed description of the applicant's proposal for the use of the grant funds and the specific dollar amount requested as well as an estimate of the number of students with learning disabilities who will benefit from the use of the grant funds.

Additionally, the application contains a section to indicate if the requested funds are available from another source and whether or not the applicant's school has been awarded a Challenge Grant in the past. While the application does not specifically require a quote on the proposed supplies, most applicants do attach this information as supporting documentation of the needed funds.

I encourage all clubs to have their Education chair to access the website and print all of the needed information on the Challenge Grant and to forward that information to appropriate local school officials. I know there are many schools that could use these funds for the benefit of their students, and the process is quick and simple.
