# GFWC-MFWC President-elect and State Membership Chairman Dr. Carolyn S. Tedford

Greetings Federated Sisters,

Oh, what a wonderful and amazing adventure I have had reading each of the club's membership reports. The volunteer hours, donations, activities and projects the clubs' reported truly reflected the goals and intentions of the GFWC "Sparkle and Shine" retention, recruitment, mentoring and recognition campaign which encompasses Strengthening Relationships, Sharing your Passions, Harmonious Connections and Shining Bright. Clubs fostered "Unity in Diversity", made communication connections by utilizing GroupMe, Facebook, Membership Portal, and text messages to encourage attendance and involvement in activities and projects. Clubs provided flexibility and a wide ray of opportunities through membership categories based on the needs of the members for their clubs and promoted recruitment of members throughout the year through various membership recruitment events.

#### **Membership Numbers**

- Nine of thirteen General Clubs with a total 179 members from Northern District reported 51 projects, 160 volunteer hours, and \$496 dollars spent in Membership.
- \* Seven of twelve General Clubs with a total 117 members from Central District reported 42 projects, 1,201 volunteer hours, and \$4,383 dollars spent in Membership.
- \* Six of nine General Clubs with a total of 187 members from Southern District reported 51 projects, 2,631 volunteer hours, and \$13,120 dollars spent in Membership.
- \* Pontotoc Juniorette with a total of 32 members reported 3 projects, 3 volunteer hours and \$60 in Membership.
- Dixie Daisy Juniorettes with a total of 16 members reported 5 projects, 5 volunteer hours and \$479 in Membership
- \* Juniorette Diamonds with a total of 22 members reported 15 projects, 163 volunteer hours and \$2,382 in Membership.
- \* GFWC-Mississippi had 22 General Clubs and 483 members that reported 147 projects, 3,995 volunteer hours, and \$17,999 dollars spent in Membership to GFWC.
- \* Pontotoc Juniorettes, Dixie Daisy Juniorettes and Juniorette Diamonds with a total of 70 members reported 23 projects, 171 volunteer hours and

\$2,921 dollars spent in Membership to GFWC.

Membership as of February 2022 was:

662 General Club Members 125 Juniorette Members Total of 787 Members



Our Current Membership as of February 2023 was as follows:

683 General Club Members 186 Juniorette Members Total of 869 Members

Ladies, I encourage you to continue to work hard and continue to live that volunteer spirit. Thank you all for your hard work.




# Messages from Appointed Officers and Chairmen

#### Parliamentarian News From Suzanne Byrd Poynor

At the Winter Board Meeting on Saturday, February 18, 2023 at the Senior Center in Richland, Mississippi, these proposed Standing Rule changes were presented to the Executive Board with the recommendation of the Constitution and Bylaws Committee with the approval of the Executive Committee.

The following changes were approved by the Executive Board. These approved changes will take effect immediately.



IF ADOPTED, WILL READ: No member Officers, Community Service Program, Committee, and Special Appointments Chairmen shall not offer material or monetary awards for State sponsored contests, except Youth Art and GFWC approved programs and projects, without the consent of the GFWC-Mississippi Federation of Women's Clubs Executive Committee or the Executive Board.

RATIONALE: To clarify.

**2. Amend Standing Rule 4** to clarify that no member may solicit contributions from members or individual clubs unless they are approved by GFWC, the state federation, or the state Executive Committee or Executive Board.

IF ADOPTED, WILL READ: <u>No member Officers, Community Service Program, Committee, and Special Appointments Chairmen</u> shall not call upon individuals or individual clubs for contributions unless they are approved by the GFWC, the GFWC-Mississippi Federation of Women's Clubs, the GFWC-Mississippi Federation of Women's Clubs Executive Committee or the GFWC-Mississippi Federation of Women's Clubs Executive Board.

RATIONALE: To clarify.

**3. Amend Standing Rule 12** to delete the references to the M. Colie Covington Endowment Fund and the Headquarters Fund.

IF ADOPTED, WILL READ: The per capita dues for local club members shall be the amount proposed by GFWC and by GFWC-Mississippi Federation of Women's Clubs for the fiscal year, June 1 - May 31. Dues collected shall be divided within the discretion of the Finance Committee among the following: GFWC dues, State Federation Fund, M. Colie Covington Endowment Fund, Headquarters Fund and the Mississippi Clubwoman.

RATIONALE: To conform to Headquarters exit.

4. Delete Standing Rule 15.

IF ADOPTED, WILL READ:

- 15. M. Colie Covington Endowment Fund
  - A. The elected officers shall constitute a Board of Trustees, which shall have control over the funds as empowered by the Executive Board to act. The Board may grant to the Trustees the power to sell,

assign or transfer any of the investments or securities belonging to the M. Colie Covington Endowment Fund when in the interest of the proper administration and conservation of its assets.

- B. A detailed accounting of all items of income and disbursements shall be made by the Trustees to the Executive Board whenever called upon.
- C. All interest from the M. Colie Covington Endowment Fund accruing during the year shall be transferred to the State Headquarters Fund at the close of the fiscal year.
- D. Funds derived from the M. Colie Covington Endowment Fund shall be kept on the Treasurer's books as a separate account.

RATIONALE: To conform to the Headquarters exit.

PROVISO: This amendment to the Standing Rules will only take effect if the M. Colie Covington Endowment Fund is removed from the Bylaws by a vote of the membership at the 2023 State Convention.

5. **To amend Standing Rule 16.B.4** to delete an old reference to Mississippi Institutions of Higher Learning (which usually means the eight public Mississippi universities and does not include private schools) and clarify a prior amendment that allows the Hebron Memorial Scholarship to be awarded to any student at a public or private Mississippi college or university that offers a 4- year degree or a graduate degree.

IF ADOPTED, WILL READ: This scholarship shall not be limited to any particular year in college<u>or</u> graduate school, but is limited to a Mississippi Institution of Higher Learning. A Mississippi Institution of Higher Learning is defined as a public or private Mississippi university or college with an undergraduate program of four-years and/or a graduate program The scholarship must be sent directly to the school institution the grantee plans to attend. The Scholarship Grantee should attend the State Convention or State Board Meeting to receive recognition.

RATIONALE: To clarify.

**6. Amend Standing Rule 19.C** to clarify the makeup of the Sarah Peugh Butterfly Scholarship Committee, given that GFWC no longer has more than one area under the Education Community Service Program.

IF ADOPTED, WILL READ: The GFWC-Mississippi Federation of Women's Clubs Sarah Peugh Scholarship recipient will be selected by a panel to include the GFWC-Mississippi Federation of Women's Clubs President and two representatives of the Education Community Service Program committee of three appointed by the State President. The recipient will be notified at least one week prior to the State Convention.

RATIONALE: To conform to current practice.

#### 7. Delete Standing Rules 26 and 27.

IF ADOPTED, WILL READ:

26. The GFWC-Mississippi Federation of Women's Clubs 1935 Society is established to encourage donations for the restoration, renovation, and maintenance of the GFWC-Mississippi Federation of Women's Clubs Headquarters Building. Membership in the GFWC-Mississippi Federation of Women's Clubs 1935 Society will be available to donors of any amount, whether GFWC-Mississippi Federation of Women's Clubs clubs, club members, and/or other interested persons

or organizations or businesses. The Executive Committee, in consultation with the Chairman of the Headquarters Committee, is authorized to expend these funds for the aforementioned purposes.

- A. Charter members shall be the first 100 contributors.
- B. Donors shall be designated as follows:
  - 1. Grand Patron for donations \$1,000 or more, and
  - 2. Patron for donations of \$500 to \$999.99.

Funds derived from contributions to the 1935 Society shall be kept on the Treasurer's books as a separate account and shall be solely dedicated to the restoration, renovation, and maintenance of the GFWC-Mississippi Federation of Women's Clubs Headquarters Building.

27. The Executive Committee, in consultation with the Chairman of the Headquarters Committee, is authorized to conduct all business related to the occupancy of the Headquarters apartment. This shall include, but not be limited to: removing unsuitable Occupant(s); searching for suitable Occupant(s); and authorizing the proper elected officers to execute agreements with selected Occupant(s).

RATIONALE: To conform to the Headquarters exit.

# GFWC-MFWC Education and Libraries Chairman Lisa McGee


Greeting from the Northern District! I enjoyed reading your reports and about the awesome projects! I was amazed at how creative club women are.


#### MFWC Historian Libby D. Everett, Chairman

# MLC and MFWC —A Proud Past and a Promising Future

President Theresa Buntyn' passion for "Getting Back to our GFWC Roots" is contagious! Our members are discovering innovative ways to collaborate with local libraries to reconnect and strengthen services, promote advocacy, and support leadership. The GFWC-Mississippi Federation of Women's Clubs was integral in establishing public libraries and the Mississippi Library Commission.

Here's some historical context to consider.

#### **Development of Public Libraries in Mississippi**

In 1926, 83 percent of the state was still without free library service. By 1970, all 82 counties in Mississippi were supporting, to some degree, free county-wide library service. The following are two significant steps in the development of public libraries in Mississippi:

- Carnegie Libraries (1908 -1916) Mississippi, like many other states, benefited from the philanthropy of Andrew Carnegie. The Carnegie Foundation gave more than \$185,500 to establish libraries in Mississippi. Eleven public library buildings were erected in ten communities across the state in eight years. Libraries were built in Houston, Mound Bayou (which never functioned as a library), Meridian (a main branch and a Negro branch were created), Greenwood, Clarksdale, Jackson, West Point, Okolona, Vicksburg, and Gulfport. Today only Clarksdale, Houston, and Okolona utilize the Carnegie buildings as libraries.
- **Federation of Women's Clubs** (1925 -1975) Without the support and steadfast resolve of the women in the various women's clubs in Mississippi, public libraries would have taken a back-row seat to many other community projects. However, in 1925, the state federation of women's clubs determined to ask for library service in every county in the state. In 1926 the Mississippi Library Commission was established and adopted the same goal as the women's clubs. It would take more than 50 years to accomplish this goal.

We are champions, but we still have work to do. Building on a solid history and a renewed commitment, we have an opportunity to encourage legislative and public support for the Mississippi Library Commission.

Did you know that the **Mississippi Library Commission** (MLC) offers a wide variety of direct and indirect services to libraries, government agencies, and the citizens of Mississippi? Some of the services provided include:

- Online Resources-MAGNOLIA, Talking Book Services (TBS), LearningExpress Library, and Hoopla
- Book Club in a Box Kits ten copies of the same book along with discussion questions
- Board Games
- STEM Kits
- BookMatch



Elvis Aaron Presley was born in Tupelo, Mississippi, on January 8, 1935, to Vernon and Gladys Presley. Born in a two-room house built by his father, grandfather and uncle, Elvis was one of twin brothers born to the Presleys. His brother, Jessie Garon, was stillborn. Elvis grew up in Tupelo surrounded by his extended family including his grandparents, aunts, uncles and cousins.

#### THE LITTLE SHOTGUN HOUSE


In 1934, Vernon Presley borrowed \$180 for materials to build a small frame house in East Tupelo. Vernon's father Jessie and Vester, his brother, helped with building the little shotgun house. It was in this humble two-room home lit by a single light bulb in each room that Elvis Aron Presley was born on January 8, 1935. Elvis was one of twin brothers born to the Presleys. His brother, Jessie Garon, was stillborn.

The family lived in the house about three years until the home was repossessed when Vernon could not repay the \$180 loan. Vernon and Gladys worked various jobs while in Tupelo and moved several different times during the thirteen years they resided in Mississippi. The Presley family lived in other locations in Tupelo until Elvis was thirteen years old when they moved to Memphis.

The **Elvis Presley Birthplace** is a historic museum site in Tupelo, Mississippi dedicated to the preservation of the birthplace of American musician Elvis Presley. It is listed on the Mississippi Blues Trail.<sup>[1][2]</sup>

The museum site includes the birthplace home of Elvis Presley, a museum, a chapel, and the Assembly of God Church building where the Presley family worshipped. Financially, times were hard on Vernon and Gladys, and they had to move out of the shotgun house when Elvis was only a few years old for lack of payment. Vernon and Gladys worked various jobs while in Tupelo and moved several different times during the thirteen years they resided in Mississippi.<sup>[3]</sup>

An F5 tornado struck eight miles (13 km) outside the city on April 5, 1936. The catastrophic tornado killed hundreds but spared the Presley's house and the family was unharmed. [4][5]




