After reviewing suggestions from club members across the state, I am excited to share with you some exciting changes to club reporting.



- 1. MFWC is implementing 100% electronic reporting this year. All reports will be submitted using the fillable reporting forms on our website. Your executive board and committee chairs are here to help the clubs that have not yet transitioned to electronic reporting. Since the option of mailing reports has now ridden off into history with the Pony Express, we are here to help make this journey smooth for all.
- Clubs will be divided into two classifications at the district and state levels, similar to how we judge yearbooks and scrapbooks. Each classification will have 1st—5th place awards.
 - Classification A 20 members or less
 - Classification B 21 members or more.

With this new classification, more clubs will receive deserved recognition for their work. We are excited to spotlight more of you with this new system. The creativity awards and the Top 10 projects will continue to be awarded to the top clubs overall, including Juniorettes. These two areas will not be divided into classifications.

3. Juniorette awards will now be judged at the district level. With this change, we look forward to seeing more Juniorette clubs report. Juniorette clubs will also be divided into classifications A and B.

As the new club years begin, ramp up your reporting mindset and prepare your club members to begin recording all those volunteer projects and volunteer hours.

Why do we report? I'm glad that you asked.

- 1. Reporting helps clubwomen keep records of the work completed each year.
- Reporting is a valuable tool in preserving the history of your club and becomes a part of the history of MFWC and beyond.

- 3. Reporting is how your club receives the deserved recognition for the services your clubwomen provide to your communities.
- 4. Reporting adds a little spice to the end of your club year by participating in friendly competition as rewards are presented on the district and state levels. While not all clubs are interested in this area, your reports will help MFWC be well-represented at the National/International level.

We aim to have 100% of Women's and Juniorette clubs report this year. Even if your club only focuses on one of the 17 areas, please submit that one report. Your volunteer hours will be added to the Mississippi totals for GFWC. You matter!

A wealth of information can be found on social media, in the newsletters, and on the MFWC and GFWC websites.





Bylaws: Why Needed!

Bylaws serve as a foundational framework for the oversight of your club. They outline the rules and procedures for decision-making, member rights, and responsibilities.

Bylaws usually note leadership

structure, meeting protocols, and voting processes, providing clarity and guidance for members.

By establishing clear guidelines, bylaws help prevent conflicts, promote accountability, and ensure that the organization adheres to its mission and values.

Ultimately, they are essential for maintaining order and fostering a collaborative environment.

Think of these questions:

- What is your quorum to conduct business? Is that information is outdated? Consider revising!
- How do you vote on new members and officers? Is the process unclear or not followed? Consider revising!
- ♥ When do you meet? Do you follow that requirement? If not, consider revising!
- ◆ Are your standing committees still relevant? If not, consider revising!
- Are there other outdated practices included in your bylaws? If so, consider revising!

Your club bylaws should have an article that spells out how they can be amended. Follow that requirement. Typically, the membership must the provided notice of the proposed changes prior to the vote. Most bylaws require a 2/3 vote to made amendments.

2024 has been a remarkable and transformative year at Mississippi Public Broadcasting. With the storytelling of documentaries like Ken

Burns' upcoming **Leonardo da Vinci** (will air in November); innovative science and insights on **NOVA's** *Decoding the Universe: Cosmos*; and new **MASTERPIECE** programs like *Alice and Jack*, MPB has been your companion. From world-class reporting on **Morning Edition** to inspiring local finds on **Mississippi**

Antiques Showcase, MPB enriches your days with information, exploration, intrigue and laughter when you need it most.

The educational department of MPB has been reorganized this year under the leadership of Dr. Marvin Jeter, and it is now called **MPB Learning** and provides resources to teachers, librarians, students, and community leaders. There is a Digital Education Network available (DEN) that school educators are encouraged to sign up for. There are many new programs available for Early Childhood including free lesson plans.

MPB Classroom TV has resources available in the following categories: ▼Early Childhood ▼Literature ▼Math ▼Science ▼Health & Welfare ▼Music & Art ▼English & Language ▼Social Studies

MPB is working with Workforce Development in the state through Exploring Clubs in which professionals detail their professional careers to high school students. Through Accelerate Mississippi – career coaches are working with the local high schools as well as "middle colleges" in high schools where students receive college credit for advanced courses taken during their high school years. The basic values taught by Mr. Rogers in "The Neighborhood" are once again being emphasized. Once a quarter MPB will go to a community for a "Family Fun Day".

Don't forget that our clubs can partner with MPB on *Read for the Record* on Thursday, October 24th. The featured book this year is "Piper Chen Sings" by Phillipa Soo. Please contact Leslie Hebert, MPB Literary Specialist, at leslie.hebert@mpbonline.org to order your club's books.

Your club might consider having a speaker from either a MPB department or the MPB Foundation speak to your club. My club in Crystal Springs had Dr. Marvin Jeter and Leslie Hebert speak at our April meeting. Our club invited teachers and librarians from CS Elementary and Copiah Academy to learn about the resources available from MPB for their classrooms and libraries. Our club members took up extra monetary donations and presented to Dr. Jeter for the MPB Foundation to help with its educational programming needs. Hebron Memorial Scholarship Chairman

A scholarship, known as the Hebron Memorial Scholarship, shall be maintained by the GFWC-Mississippi Federation of Women's Clubs,

Inc. Only female residents of



Mississippi shall be eligible to apply. This scholarship shall be a grant, and only one may be granted during one year, except with the approval of the Executive Committee. A holder of the scholarship is eligible for consideration by the Scholarship Committee to receive the grant for an additional year or years.

The following rules shall govern this scholarship:

◆The maximum amount of this grant shall be one thousand dollars (\$1,000.00). Messages from Executive Board Page 11

- ◆The applicant must meet the following requirements:
 - Application must be made in writing to the Chairman of the Hebron Memorial Scholarship Committee before February 1 for use within that year.
 - The applicant must be a resident of Mississippi, having graduated from an accredited high school with a good scholastic average; or in the case of an applicant for graduate school, she must have graduated from an accredited college and must be attending an accredited graduate school.
 - 3. The applicant must be endorsed by three (3) members of the GFWC-Mississippi Federation of Women's Clubs.
 - 4. The application must be accompanied by recommendations from three (3) other persons relative to scholarship, character, and qualities of leadership.
 - 5. The applicant must signify her intention of completing her degree within a four-year period.
- ◆Preference will be given to areas of service where it is felt there is the need in the state.
- ▼This scholarship shall not be limited to any particular year in college, but is limited to Mississippi Institution of Higher learning. The scholarship must be sent directly to the Institution the grantee plans to attend. The Scholarship Grantee should attend the State Convention or State Board Meeting to receive recognition.

To Apply: Complete the GFWC-MFWC Hebron Memorial Scholarship Application Form. You can download this form by clicking this link. The submission email must be received by 11:59 p.m. on February 1 in the year in which entries will be judged.

An outstanding environmental project is completed yearly by one group in northern Mississippi. This yearly summer project expresses thanks to those individuals who keep



our roadsides clean in the summer. The northern Mississippi club partners with a community church in the area.

The highway workers (inmates) are sent to an area in the county with law enforcement personnel. They work to collect trash on the roads. This work continues daily until all roads have been cleared from trash. An incentive in the form of payment is also given to the inmates from law enforcement. Not all inmates are given the chance to serve the county. Only those who are serious about the project and show good behavior are included.

This is a way for the church and club to show that we all make mistakes, but we still can work productively to keep our environment clean and appealing.



Promoting the Arts is something we are both passionate about. In this, and future articles, we will share projects we have worked on in our own areas that might inspire you. My local club helped sponsor the establishment of an Arts Council in our town. Through the Arts Council, we have been able to recognize local artists and provide opportunities for them through events like art classes, markets, monthly gatherings, group outings, and places to display their artwork. Several of our club members participated in a glass blowing group outing at a local studio with Arts Council members. 

Epsilon Sigma Omicron (ESO) Chairman

Do you enjoy reading or being a part of a book club. Then consider joining the GFWC-MFWC ESO Chapter.



Epsilon Sigma Omicron (ESO) is an honorary educational society open to all per-capita dues paying GFWC federated clubs. More than 70 years ago, the ESO program became a permanent part of the GFWC Education Community Service Program. Through ESO, clubwomen are given direction in planned reading for self-enrichment and personal growth. Over the years, many GFWC clubwomen have profited from this unique self-improvement program, seen as vital by the members it directly benefits. The purpose of ESO is to provide clubwomen with a structural reading program, which is educational and stimulates a desire for self-improvement.

Interested GFWC members must first pass through the ESO pledge stage before they can become ESO members. The completion of an ESO pledge application is needed before a pledge can begin working towards membership status. The pledge application must be sent GFWC-MFWC ESO C hairman Theresa Berryhill, who will begin tracking the pledge's progress. A pledge qualifies for membership at her own pace, finishing in a few weeks or working slowly throughout a longer period of time. After proper completion of 16 books, the pledge receives a certificate verifying her ESO membership from her club and/or state.

Reading is, of course, the main responsibility of an ESO member. Once books are completed, the member is required to complete a brief form, giving the title and brief opinion of the book read. The form is submitted to the State ESO chairmain to keep track of each member's ESO levels, which are based on the number of books read. State ESO chairmen will issue certificates and awards based on report forms received.


Acts of EVERYDAY Leaders

INTRODUCING THE GFWC LEGISLATIVE LADDER



It is exciting to introduce the 2024-2026 GFWC Legislative Action Plan for clubs. Clubs are challenged annually to "step up" to EDUCATE, ENGAGE, EMPOWER by tackling the varied concrete steps of the Legislative Ladder. Steps do not need to be completed sequentially. Individual steps may be reported only once each reporting year but may be engaged in multiple times during the club year with the more steps achieved, the more points to report. The point value identified for each step is the total that may be accumulated annually. Certificates will be awarded for clubs reporting activities with point values totaling 35 points or more. Individual club recognition will take place during the 2025 and 2026 GFWC Annual Conventions.

The first step on the ladder is to increase individual member registration in the Legislative Action Center (LAC). Keep in mind that simply by registering, members receive notification of legislative action supported by GFWC Resolutions. Although immediate action is not required, the LAC does supply timely information and education. When a member chooses to "take action" after reading the proposed message and/or writing specific individualized language, a response may be received from the Congressional representative(s), as listed in the introduction to each alert; and may help that representative decide to support the legislation. Sign up today https://www.gfwc.org/get-involved or use the QR code in the sidebar.

The ladder's second step is to request a proclamation from a "decision-maker" (i.e., town council, mayor, state or U.S. Congressman, governor) recognizing, for example, a "week" promoted by one of the program areas, a club anniversary, etc., for a value of 5 points. To enable clubs to begin use of the Ladder, consider using the following Proclamation recognizing the significant legislative milestones in the quest to support abused women and children, legislative milestones long supported by GFWC clubwomen. Find the fillable report form on the home page of the GFWC Digital Library in the Member Portal.

Q: Is the Legislative Ladder replacing the Scavenger Hunt?

A: The Legislative Ladder was built based on the successes of the previous administration's Scavenger Hunt; so yes, the Legislative Ladder will be the only Club Connection Initiative.


